The NYS Office of Addiction Services and Supports Application Services website is designed to make it easier and more efficient for OASAS licensed and/or funded providers to report required information to OASAS.

Access to this website is limited to authorized users.

Like all online resources, we recognize that users of this website are concerned about their privacy.

This policy describes OASAS's privacy practices regarding information collected from authorized users of this website including what data is collected and how that information is used. OASAS may, at its sole discretion, change modify, add, or delete portions of this policy without notice. Information Collected When You Visit this Website

When visiting this website OASAS may automatically collect and store any of the following information about your visit:

1. The Internet Protocol address and domain name of your Internet service provider.
The Internet Protocol address is a numerical identifier assigned either to your Internet service provider or directly to your computer, which can be used to direct internet traffic to you.
2. The type of browser and operating system you used.
3. The date and time you visited this site.
